TOWN OF STONEWALL - BY-LAW NO. 11-24

The Town of Stonewall (the "Town") submits By-law No. 11-24 (the "Proposed By-law") under Section 320(4) of *The Municipal Act* for the Board's review and approval. The Proposed By-law was received on March 6, 2024.

The Proposed By-law attached as Appendix "A", proposes to levy a Special Services Tax to levy a mill rate to raise up to a maximum of \$455,000.00 on all taxable and grant-in-lieu properties within the boundaries of the Town as described in Schedule "B" to the Proposed By-law. The Proposed By-law excludes all lands annexed in 2024 by the Town. Part of the annexation agreement between the Town and the Rural Municipality of Rockwood requires that the annexed lands (listed in Schedule "A" part a) to the Proposed By-law) be excluded from paying the cost of certain urban services they do not benefit from. The Municipal Board approved the proposed annexation in 2022 (Municipal Board Order No. E-22-103).

The mill rate levy is determined by dividing the net cost of these services by the total portioned assessment values of all affected properties. Based on the Town's 2024 portioned assessment amount of \$348,230,420.00, a mill rate of 1.307 mills will be required.

Calculated on a residential property with a market value of \$200,000.00 (portioned value of \$90,000.00), a \$117.63 special service tax would be levied in 2024.

The levy is for purposes of a Special Service Plan regarding street lighting, police protection, recreation support (parks and arena services) and snow removal within the Town for the year 2024.

The Board received no objections to the Proposed By-law.

In dealing with the Proposed By-law, the Board must look at its duty which is set out in Section 64 of *The Municipal Board Act*, which states:

Duty of board

- 64** In dealing with an application the board shall consider
(a) the nature of the work, undertaking, or object proposed;

- (b) the necessity or expediency thereof;
 - (c) the financial position of the local authority; and
 - (d) any other relevant matters;
- and may refuse the application or require the local authority to vary the application, or may grant the application in whole or in part, or subject to conditions.

After the review of the Special Service Plan, the Board is satisfied that the Special Service is needed and finds that the Proposed By-law is reasonable and will be approved.

THEREFORE, THE BOARD ORDERS THAT:

1. Town of Stonewall By-law No. 11-24 **BE APPROVED**, subject to the following amendments:
 - (a) In Schedule "A" to the By-law, at Clause C, in the fourth column of the table, delete both instances of "\$1,090,000" and replace with "\$731,000".
2. A filing fee of \$50.00 be paid by the Town of Stonewall.

APPENDIX "A" TO

Being a By-Law of the Town of Stonewall to establish a rate for urban services being provided to the Town of Stonewall excluding annexed lands for 2024.

WHEREAS Section 312 of *The Municipal Act* of Manitoba, provides in part as follows:

312 If approved by by-law, a municipality may provide, as a special service to all or part of a municipality, one of more of the following:

- (b) snow removal and dust control;
- (c) tree planting or control of a plant or tree disease;
- (d) grass and weed cutting and control;
- (g) recreation support services;
- (h) street lighting;
- (i) fire and police protection services;

AND WHEREAS subsection 320(1) of the Act provides as follows:

320(1) Subject to subsections (2) to (6) and subsection 321(4), a council may by by-law

- (a) approve the local improvement or special services as set out in the plan or proposal; and
- (b) authorize the municipality to impose taxes as set out in the plan or proposal.

AND WHEREAS the Council of the Town of Stonewall has prepared Special Services Plan No. 2-2023 to establish a rate for the urban services identified as street lighting, police protection, parks & arena services, and snow removal as a special service pursuant to Part 10 of the Act;


AND WHEREAS the requirements as prescribed in section 318, 319, and 320 of the Act have been complied with;

NOW THEREFORE the Council of the Town of Stonewall, in open council assembled enacts as follows:

1. That "Annexed Lands" means the lands located in the five quarter sections identified as: NE35-13-1E, SE35-13-1E, NE26-13-1E, SE26-13-1E, and NW19-13-2E;
2. That pursuant to subsection 320(1) of the Act, the Town of Stonewall approves Special Service Plan No. 2-2023 attached hereto as Schedule "A";
3. That the Town of Stonewall levy an annual special service tax upon all properties within Town limits, excluding the annexed lands, identified in Schedule "B" as hereby attached.

As part of the discussion regarding the annexation and the transition of the use of the land from agricultural and rural to urban the annexed lands would not pay for urban services that they were not receiving, or which are compensated through an alternative funding arrangement. These urban services have been identified as street lighting, policing, parks & arena, and snow removal.

The following special services plan identifies specific services that are not being provided to residents or property within the annexed lands or for which alternative funding arrangements have been made.

b) The Special Service Area to be Levied

The Special Service Area to be levied includes all taxable and grant-in-lieu properties within the boundaries of the Town of Stonewall on December 31, 2023, more specifically identified as the original nine quarter sections as follows:

c) Estimated Cost of the Service

The following table identifies estimated amounts for the urban services included in this plan. Revenue and expenses have been estimated for the services listed. In order to accomplish the goal of creating an at large mill rate reflective of the mill rate that would be paid by the annexed lands prior to annexation a portion of at large mill rate for the entire Town has been included in the table as a recovery.
