

**TOWN OF STONEWALL
BY-LAW NO. 01-21**

Being a By-Law of the Town of Stonewall to repeal By-Law No. 17/12 which regulated Sunday and Holiday Shopping.

WHEREAS the Province of Manitoba passed *The Retail Business Hours of Operation Act* which came into effect December 12, 2020;

AND WHEREAS *The Retail Business Hours of Operation Act* repealed *The Retail Business Holiday Closing Act* and the regulations under that Act;


AND WHEREAS the Town of Stonewall By-Law No. 17/12 to regulate Sunday and Holiday Shopping hours was passed under the authority of *The Retail Business Holiday Closing Act* which is now repealed;

NOW THEREFORE BE IT HEREBY ENACTED as a By-Law of the Town of Stonewall, in meeting duly assembled that By-Law No. 17/12 be hereby repealed in its entirety.

**TOWN OF STONEWALL
BY-LAW NO. 17/12**

**BEING A BY-LAW TO PERMIT SUNDAY AND HOLIDAY
SHOPPING IN THE TOWN OF STONEWALL**

WHEREAS under the Retail Businesses Holiday Closing Act (the "Act"), a municipality may by by-law, in addition to those exemptions provided in the Act, provide the following further exemptions to Sunday and holiday shopping:


- a. Every retail business establishment in the municipality or territory where the number of persons, including the owner, employed for the sale of goods or services does not normally exceed four (4) persons at any one time; and
- b. Every retail business establishment in the municipality or territory where more than four (4) persons, including the owner, are ordinarily employed for the sale of goods or services at any one time, but only if
 - i) The holiday is other than New Year's Day, Good Friday, Easter Sunday, Canada Day, Labour Day or Christmas Day, and
 - ii) That retail business establishment does not admit members of the public therein or sell or offer for sale any goods or services before 9:00 a.m. or after 6:00 p.m. on the Sunday and or holiday.

NOW THEREFORE the Council of the Town of Stonewall in session duly assembled enacts as follows:

1. THAT the following further exemptions to Sunday and holiday shopping as provided for in the Act are hereby declared to be in force in the Town of Stonewall:
 - a. Every retail business establishment in the municipality or territory where the number of persons, including the owner, employed for the sale of goods or services does not normally exceed four (4) persons at any one time; and
 - b. Every retail business establishment in the municipality or territory where more than four (4) persons, including the owner, are ordinarily employed for the sale of goods or services at any one time, but only if
 - i) The holiday is other than New Year's Day, Good Friday, Easter Sunday, Canada Day, Labour Day or Christmas Day, and
 - ii) That retail business establishment does not admit members of the public therein or sell or offer for sale any goods or services before 9:00 a.m. or after 6:00 p.m. on the Sunday and or holiday.
2. THAT By-Law No, 25/95be hereby repealed in its entirety.
3. THAT this By-law shall cited as the "Sunday Shopping By-Law".
